Sub: College Development Council - UG, PG & Professional Colleges - Stipulate dates for payment of affiliation and other fee - enhancement of the affiliation and other related fees for the academic year 2018-19 by 10% - following the same pattern/ procedure adopted for the academic years 2016-17 & 2017-18 without late fee and with late fee for the Academic year 2018-19 - Initiate action against those colleges which failed to pay affiliation fee - Orders - Issued - reg.

I am by direction to inform you that affiliation and other fee for the academic year 2018-19 increased by 10%, the fee payment schedule is given below for granting temporary affiliation to all the UG & PG Colleges for the academic year 2018-2019.

The details of fees to be paid in respect of affiliation fees, admission registration fees or special fees, Inter-University Tournaments (IUT) fee, Sports affiliation fee, JKC fee, and Research journals subscription fee, are available in our Website www.krishnauniversity.ac.in.

S. No.		Courses	Last Dates
a.	Last date for payment of affiliation fees without penal fee to the University	UG, PG and Professional Courses	30.09.2018
b.	With a penal fee of 10% on Affiliation fee	UG, PG and Professional Courses	15.10.2018
c.	With a penal fee of 25% on Affiliation fee	UG, PG and Professional Courses	31.10.2018
d.	With a penal fee of 50% on Affiliation fee	UG, PG and Professional Courses	13.11.2018

Further, the Vice-Chancellor has ordered that if any College has failed to clear the payment of fee even after 13.11.2018, they will attract 100% penalty up to 15 days from the last date mentioned above. Also the Vice-Chancellor has ordered that if the management of any College failed to pay affiliation fee, even after all the last dates mentioned with penal fee, affiliation order and the examination results of such college will be kept under pending category and prevent such college for making admissions in the next academic year viz., 2019-2020 and all other affiliation related fees are to be paid to University within one month time from the closing date of admissions for the year 2018-19.
